

Councillor Lee reported the road from Pinchoen Green/Oak Lane to West End is in need of repairs. Due to subsidence, this road is becoming dangerous the vehicles being thrown to the left.

Councillor Lee reported on the playground gate being faulty. Also the flooring/ground surface is shrinking again. Repairs were made previously regarding this.

Councillor Duckitt reported on the Tree branch that is hanging dangerously on Chapel Lane towards the adjacent house that needs to be cut down.  
Councillor White said he would look into this.

Councillor Duckitt reported on the road leading up to the Water Tower was becoming a dump it ground. Councillor White said he would look into this.

Councillor Mr Lee reported on a request from the Village Hall for a donation towards maintenance of the hall on the outside walls and drive way that will cost around £3k. Agreed to bring to next meeting as donations had already been given to the Village Hall this year.

Councillor Duckitt reported on the letter received from Danum Drainage with regards to the maintenance of the drains in the village. As yet this is still not being done correctly.


