MINUTES OF THE MEETING HELD ON TUESDAY 23RD JUNE 2015

Chairman welcomed everyone to the meeting.

Councillor Beech reported that she was in office for 2 years this term for Norton & Askern along with Councillor Austin White & Councillor Alan Jones.

All 3 councillors would try to attend the meetings between them.

The following issues were raised to Councillor Beech:

- Grass Cutting is very poor. DMBC are not cutting the grassed areas properly and are not clearing away after. This complaint had also been made by Fishlake Village.
- Speeding. This is an ongoing problem in the village and the council would like to request illuminating 'slowdown 30 mph' signs at either end of the village. Councillor Beech reported that the speed gun would be available in September. Some villages have signs on the wheelie bins but this was thought to be supplied by the home owners.
- Hedges hanging onto the footpath next to the church making it impossible to use and residents walking on the road. DMBC to contact the home owners.
- Complaints have been received regarding Cyclists riding 5 abreast making passing on the roads impossible and dangerous. Could signs be placed to state the highway code No. 66 - *never ride more than two abreast, and ride in single file on narrow or busy roads and when riding round bends*

Councillor Mrs Lifsey reported on the 'Imagination Library' that supply books to children between the ages of birth to 5. This is a free service but needs a sponsor of £24 per child. Councillor Mrs Lifsey reported she didn't know how many children in this age range were in the village at the moment but would like the Parish Council to consider this. Councillor Mrs Lifsey said she would look into this further.

Councillor Mrs Lifsey reported on a recent litter collection that took place around the village. 12 sacks of litter were picked up. Councillor Mrs Lifsey requested that DMBC put more rubbish & dog Bins near the Church, Playing field and Marsh Hills Lane (near the seat) areas.

Councillor Mr Duckitt reported on 2 potholes on Oak Lane near Went Bridge that were in urgent need of repair. Also Wormley Hill – South of Green Farm, this road was in need of repairs, either Tarmac or chippings was needed. Lorries & Buses use these roads and are now getting even busier.
